

## CRNA BOARD MEETING MINUTES - 10 January 2022

The meeting was called to order at 4:34PM. Board members in attendance: President, Dave Zeemont; Treasurer, Bob Crowley; Secretary, Mike Buchanan; Director Al Shawala & Director David Johnson. Association members participating included Walter & Gail Gomez, Ginger & Kelly Dickson, William & Maxine Webber, and Dave Wright.

<u>December minutes:</u> Approved without change.

<u>Treasurer report</u>: The December treasurer report was presented and accepted by the board. December expenses included standard utilities plus a \$4463.56 for gate motor replacement, \$3123.87 in landscape improvements and a \$20,000 transfer to the road reserve. The \$609.07 higher than normal water bill included a one-time cost to disconnect and remove the meters from two islands. Additionally, the 2022 budget was presented and approved by a unanimous board vote. Finally, the statutory 3-year financial compilation was provided. This will be briefed at the annual members meeting on 27 January and included in those minutes.
